I understand that if any of the checks of the requested documentation prove unsatisfactory this Tenancy Application will expire and I may forfeit the holding deposit.

I understand that the Tenancy Application and Tenancy Agreement are offered on the basis that my Tenancy Application will form part of a full joint tenancy agreement and that if there are insufficient numbers to fill the joint tenancy, either through other applicants withdrawing or being unable to supply satisfactory documentation, payment and checks within the time period, this Tenancy Application will expire and I may forfeit the holding deposit.
